#### TERMS AND CONDITIONS

- This Agreement shall be binding upon signature.
- Sponsorships are non-refundable and non-transferable. In the event Fetch Social Club ("Company") cancels a sponsored item, the current sponsors ("Sponsor") will be contacted with an opportunity to move the contribution to another item.
- All Sponsorship amounts are listed in U.S. dollars and must be paid in U.S. dollars.
- Sponsorship fulfillment cannot be guaranteed unless Sponsorship is fully paid. Payment is due upon receipt of invoice with NET 30 terms.
- Sponsors are required to submit an approved high resolution logo in JPEG, EPS, PDF or TIFF format with the signed Agreement.
- Sponsor hereby grants Fetch Social Club a non-exclusive license to use Sponsor Brand only in connection with advertising and promotion of the selected sponsorship item and on Fetch Social Club's marketing materials and website. None of the statements set forth in this Agreement constitutes the assignment or transfer of any intellectual or industrial property rights held by Sponsor.
- Sponsor shall defend, indemnify, and hold Fetch Social Club harmless from all liability, costs, and damages relating to acts and omissions of Sponsor and its employee's, agents, and contractors associated with the Company and related sponsorship.
- If for any reason the Company does not open as expected, the Company may terminate this Agreement prior to Fetch Social Club's open date.
- This Agreement contains the complete agreement of the parties, and all prior agreements, whether verbal or written will be null and void. This Agreement shall be governed by and construed and enforced in accordance with the laws of the State of Oklahoma, USA (without regard to any conflict of laws principles). All actions arising out of or in connection with this Agreement shall be brought in the Oklahoma District Court, Tulsa County, Oklahoma, USA which shall be the exclusive forum therefor. The parties here to hereby irrevocably submit to the personam jurisdiction and process of the Oklahoma District Court, Tulsa County, Oklahoma, United States of America, and agree that service by certified mail to their addresses shall constitute sufficient service of process.

Authorization and Qualification: This agreement and contract ("Contract") shall be binding upon its acceptance as set forth below. The Company may cancel or terminate this Contract at any time if Sponsor fails to abide by any provisions, terms or conditions of this Contract. The appropriateness of a product or logo to be displayed and whether such product or logo may be displayed, shall be determined by the Company at their sole discretion. Exclusive sponsorship is based on a first-come basis. Should the preferred sponsorship already be claimed at time of agreement submission, the Company shall consult the Signee on alternate options or refund should an appropriate sponsorship not be available.

Payment Terms: Sponsorships received during business development will have NET 30 payment terms from date of submission. Signee and Sponsoring company understands and agrees that the entire sponsorship amount will be due on or before 30 days after date of invoice to retain sponsorship rights. Official logos for sponsoring companies should be provided on or before time of payment. Sponsors owing balances to the Company will not be permitted to display logo until payment is received in full. All payments must be received prior to July 1, 2025, to be guaranteed for inclusion in signage during the Grand Opening events.

Cancellation Terms: The signature of an Authorized Representative on this Contract binds the Sponsor to this payment and cancellation schedule, even if the Authorized Representative is no longer employed by sponsoring organization. A signed contract obligates the Signee, or represented Sponsor, to pay the entirety of the sponsorship amount. Defaults in payment may result in reassignment of sponsorship or cancellation. No cancellations shall be accepted unless received in writing and acknowledged by the Company. The date upon which the notice of cancellation is received shall apply as the official date of cancellation. Upon Sponsor notification of cancellation, the Company retains the right to resell the sponsorship with no further obligation to the Sponsor. Upon cancellation, Signee and represented organization shall also forfeit all privileges, including but not limited to removal of company listing from promotional materials and the Fetch Social Club website. Should the Company be unable to include sponsored item(s) in construction as planned, the sponsorship will not be redeemed and the invoice will not be sent unless other sponsorship arrangements have been agreed upon in advance.
